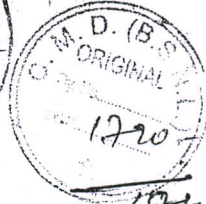

**Item no. 2. (i) Timely submission of Pension cases:
(ii) Revision of Pension of Pre-2006 pensioners is still pending:**

The matter of delay in submission of pension cases was discussed. The delay in submission of the cases results in delayed settlement of pension cases. It was requested to BSNL representatives that suitable instructions be issued to all concerned for adhering to the time lines for forwarding pension cases to the CsCA & DOT HQ.

The BSNL representatives assured to take necessary action in the matter so that the pension cases are forwarded to the CsCA & DOT HQ timely.

It was brought to the notice of the BSNL representatives that some pre 2006/2007 pension revisions are still pending. BSNL representatives requested for providing the specific details. It was decided to provide the details to BSNL.

Item no.3 . Settlement of Provisional Pension/ Gratuity cases:

It was observed that a large number of cases of provisional pension are still disbursed by the CsCA and it is decided that BSNL may review all such cases and appropriate action be taken for quick finalization of these cases.

Item no. 5. Non -supply of GPF text files Compatible with Compact package:

The matter of non supply of GPF text files was discussed. Most of the BSNL circles are sending GPF credit & debit text files not compatible with COMPACT. This is creating problem for the CCA offices. BSNL representatives were requested to take corrective action for appropriate maintenance of records.
