
Kind reference is invited to this office letter of even no. dated 15.07.2022 vide which the provisional AIEL of Departmental JAOs of 2016 Batch was circulated among Circles for checking the following details with the relevant service records:

1. The particulars furnished in all columns may be verified and corrections, if any, may be intimated.
2. The particulars in respect of Category (OC/SC/ST etc.) are to be checked and verified with respect to the entries in the first page of the service book of the executive concerned.
3. The particulars of the executives who are not presently working in BSNL due to Resignation/Demise/Superannuation/VRS/VR/Reversion/Dismissal/Removal from service etc. may be conveyed to SEA section, BSNL CO along with the date from which their service in BSNL has ended. Further, any left out names not included in the provisional AIEL may also be intimated along with relevant details.
4. The parent Circles must ensure that no JAO of Departmental JAO- 2016 batch from their circle is left out (including JAOs of Non-Territorial Circle/ JAOs on Temporary transfer to other circles etc.).
5. JAOs (both incoming and outgoing JAOs) who have proceeded on Rule 8 transfers from one circle to another must be specified separately by the circle.
6. Details of court case, if any, in r/o the JAOs of 2016 Deptl. Batch, supplementary result declared, Verification of review result of SC/ST candidates, should be intimated to this office along with the supporting documents. Further, in case of omission of name of any executive who qualified through supplementary result/SC/ST review result, such names may be intimated to this office for incorporating the same in the graduation list data.
7. The names of the candidates of JAO 2016 Deptl. Batch who opted for reversion to their substantive grade and subsequently reverted, may also be furnished in separate list.
8. In case, if there is no correction in the said provisional list of any circle, such circles are requested to issue a 'NIL' report in this regard.

II. The Circles are requested to furnish the revised and correct details with objections/ errors/ omissions after duly verifying the details from the service records, with relevant supporting documents on the subject or furnish NIL report on email id *persseaco@gmail.com* with the subject "Finalization of the provisional All India Eligibility List of Junior Accounts Officers- Departmental JAO of 2016 Batch:- Name of Circle, positively by 17.07.2023, followed by a hard-copy of the same
