Decisions of the AUAB CHQ meeting held on 21/08/2026.

An important meeting of the AUAB CHQ was held on 21.08.2026 at the NFTE Office, New Delhi. The General Secretaries and representatives of all the Unions and Associations available in Delhi attended the meeting physically, while representatives from outside Delhi participated online.

At the outset, the discussions and decisions taken in the AUAB CHQ meeting held on 08.08.2026 were reviewed. The meeting also discussed the developments that had taken place in the recent past and reviewed the actions taken by AUAB.

The meeting further deliberated on the future course of action to intensify the struggle for the implementation of the 3rd PRC in BSNL and decided to further strengthen the united struggle of the employees.

The meeting discussed in detail the demand for relaxation of the Affordability Clause for securing approval of the 3rd PRC, as well as the ongoing restructuring of Circle and BA administrations, including the Pilot Project in Uttarakhand Circle.

The meeting stressed the need for complete unity and serious preparation to make these programmes a success and to draw the attention of the Government and BSNL Management to the long-pending demand for implementation of the 3rd PRC. After elaborate discussions and submissions by all, the meeting decided to: -

- (1) Take up matter with DoT /GoI for immediate approval of the third PRC.
- (2) Oppose Restructuring Proposal with demand No Restructuring without third PRC.
- (3) Organise a countrywide agitational programme to achieve the demand of the 3rd PRC.
- (4) To decide and confirm the action on the agitational programmes in September 2026, such as an indefinite hunger strike, week-long lunch-hour demonstrations, and a Twitter campaign. Reaching out to different authorities and offices seeking intervention for the approval of the 3rd PRC will also be organised, culminating in a one-day strike in BSNL. In this connection, AUAB CHQ will organise zonal meetings to obtain feedback at the grassroots level and also to review the implementation of the agitational programmes.
- (5) Work for complete unity and serious preparation to make these programmes a success to draw the attention of the Government and BSNL Management to the long-pending demand for implementation of the 3rd PRC.
- (6) Strengthen AUAB by inviting all willing Associations and Unions of BSNL to join AUAB. Convenor will interact with General Secretaries of Unions/Associations who are presently not an active part of AUAB.
- (7) Conduct five Zonal Online Meetings of AUAB in August 2026 to strengthen the Circle/District Level AUAB activities and mass participation viz. South, North, East, West and Central and these zonal meetings will be attended by the General Secretaries, All India/CHQ Presidents, Circle Secretaries and Circle Presidents of all constituent Unions and Associations of all Circles in that zone. The dates will be decided by the Chairman and Convenor in consultation with Circles.
- (8) Conduct all meetings of AUAB CHQ in hybrid mode i.e. both in Online and Offline mode so that General Secretaries not available at Delhi also can attend the meetings.
- (9) Conduct next meeting of AUAB CHQ on 31/08/2026 at 12 noon at BSNLEU Office (Eastern Court) and conduct all Zonal Meetings before this meeting.

It was a very important meeting, which continued for about three hours. Important issues were discussed and decisions were taken, followed by a vote of thanks by the Convenor and Chairman.
