Sir,

I am directed to refer to the DO letter dt. 16.01.2024 from CMD, BSNL whereby you were advised to expedite and settle the cases specifically the cases of unauthorised absence; for a period of more than 5 years (deemed to be resigned) and for a period of 3 to 5 years on priority. It was further directed to ensure that the cases of "unauthorized absence for more than 5 years and deemed to be resigned" must be settled by 31.01.2024 and the cases of unauthorisedly absent for a period of 3 to 5 years should also be settled on priority in a time bound manner by 31.03.2024. It is noted that still cases against most circles are pending in spite of the above specific directions. The status /list of the cases pending as on 01.04.2024 are enclosed at Annexure -I.

2. You are requested to expedite the compliance of the above directions URGENTLY and submit the compliance report latest by 15th May 2024.
