Subject: Closure of Telecom Factory Alipore regarding

As part of Revival Plan of BSNL, Telecom Factory, Alipore has been identified for monetization. In reference to above cited e-files & letters of WBTC, I am directed to convey the approval of competent authority for the closure of TF Alipore for the monetization purpose with immediate effect.


On closure of Telecom Factory Alipore, the following action are to be taken by the West Bengal Telecom Circle.

- (i) All the usable raw materials, plant and machinery, test equipments, tools, jig and fixtures as well as office equipments etc. which can be gainfully utilized shall be transferred to Telecom Factory Kharagpur of WBTC for proper utilization.
- (ii) All un-usable/unserviceable raw materials, components, plant and machinery and office equipments etc. shall be disposed off immediately from Telecom Factory, Alipore Kolkata as per BSNL guidelines.
- (iii) All agreements/contracts (procurement, rental of Telecom Factory Alipore shall be reviewed and immediate action shall be taken to determine the same to ensure that no liability to BSNL arises in future
- (iv) All important legal, tax, procurement related files of Telecom Factory Alipore shall be transferred to Telecom Factory Kharagpur
- (v) All service books of existing and retired staff, medical, pension and family pension cases shall be transferred to the appropriate BSNL unit of WBTC.
- (vi) The electrical power load (contract load) shall be reduced to minimum.
- (vii) All the surplus staff (non-executives including industrial staff) other than required for activities related to disposal, essential maintenance of infrastructure and security of Telecom Factory Alipore shall be redeployed to Telecom Factory Kharagpur or other BSNL units.
- (viii) All executives of TF Cadre working at Telecom Factory Alipore (below DGM level) except those required for closure related activities shall be posted in Telecom Factory Kharagpur

- (ix) Following the above listed activities, the factory licenses and pollution control certificate etc shall be surrendered and all statutory obligations shall be ensured.

Further, action for shifting/scraping of material may be started immediately. Action for shifting of office shall be started after floating of RFP by NLMC tentatively scheduled for the third quarter (October to December 2026).
