Sir,

The undersigned is directed to refer to the subject mentioned above and to
say that the exercise for abolition of Post relating to VRS Optees in all grade of
executives/non executives in the post VRS scenario is underway. The process has
a defined urgency as it has to be finalized with the approval of BSNL Board.

Accordingly this office has been seeking data from all Circles. Initially data
was called vide this office letter dated 21.04.2020 and 28.04.2020. On scrutiny it was
found that the information provided by the Circles was at variance with the ERP
details which reflects the true number of employees availing salary in BSNL at any
point of time this was a serious lapse.

To revise the process, letter was directed individually to CGMs on their emails
seeking their personal attention to the sanctity and urgency of the exercise, vide
dated 01.07.2020 and 02.07.2020, some Circles have responded positively and after
due diligence with this office, their data has become acceptable.

However there has been no response from following Circles: AP, J&K, NE.II,
Odisha, Telangana, Calcutta TD, ALTTC, BRBRAITT, NATFM, NCNGN, BBNW, NFS,
Inspection, ITPC, NETF, ETR, WTP, TF-Jabalpur, TF-Kolkata and TF-Mumbai.

Further, following Circles have provided data but due diligence is not being
undertaken to rectify the mistakes in time, even as officers from Corporate Office are
ready to help round the clock:- Bihar, Jharkhand, Kerala, Maharashtra, Rajasthan,
UP(East), West Bengal, Chennai TD.
