It is once again worthwhile to mention that the eligibility status as well as parent circle of the candidates have been considered on the basis of e-verified data of the candidate (by the concerned circles after verifying details from service records)
- ii. The candidates mentioned in the Annexure-A shall have to furnish an undertaking, without any prejudice that in case of any discrepancy, found at any stage relating to eligibility, the candidature of such candidates shall stand cancelled.

5. The result will be subject to the outcome of court cases/ direction for the matter "reservation in promotion" and on "own merit concept" pending in different courts or any other court case on the issue related to reservation and also DoP&T instructions issued from time to time.
