

The newly formed Sikkim Telecom Circle will start functioning from Gangtok w.e.f. 1st September, 2021.

Henceforth, the Head of the newly formed Sikkim Telecom Circle will report directly to CMD, BSNL through respective Zonal Director of BSNL Board.

Following financial activities involved in demerger of Sikkim BA from West Bengal Telecom Circle and creation of new Sikkim Telecom Circle may please be carried out on Priority in consultation with respective officers in BSNL Corporate Office and ITPC, Pune: -

- a) Creation of Sikkim as a new Circle Code in SAP, and transfer of all data of Assets & Liabilities in FICO and all related SAP modules.
- b) Opening of a Circle Operational Account and Collection account, and creation of Circle CSC for payments.
- c) Appointment of Statutory Auditors and separate reporting in TR/Billing related SLR/Reports.


