Subject: Inter circle transfers of JTOs(T) under Rule 8 of BSNL Transfer Policy.


As per restructuring plan approved by BSNL Board and conveyed vide Restructuring Cell, Corporate office vide its letter no. 4-02/2021-Restg dated 23.11.2021, the revised sanctioned strength/approved manpower post VRS restructuring, effective from 01.02.2020 in r/o JTO(T) cadre has been defined as 11756. Further, the circle-wise distribution of Sanctioned strength as on 01.02.2020 in the cadre of JTO(T) has been issued vide this office letter no. BSNLCO-A/16(13)/1/2020-ESTAB dated 20.01.2022.

There is shortage of executives in the cadre of JTOs(T) pan india vis a vis Sanctioned strength. Further, the JTOs(T) in circles are not distributed in accordance with the revised circle-wise sanctioned strength of JTOs(T), leading to surplus of JTOs(T) in some circles while deficit in other circles. On the basis of availability of executives in the cadre of JTOs(T), the recruiting circles have been categorized broadly in three categories as detailed below, for the purpose of transfer/posting.

Surplus Circles (i.e Circles where working strength in cadre of JTO(T) is considerably higher than Sanctioned Strength)	Deficit Circles (i.e Circles where working strength in cadre of JTO(T) is considerably less than Sanctioned Strength)	Just Sufficient Circles (i.e Circles where working strength in cadre of JTO(T) is just above or below the Sanctioned Strength)

In this regard, it is being communicated through representations that a lot of Rule 8 transfer requests of executives in the cadre of JTOs(T) are pending in Circles. In order to ensure even distribution of JTOs(T) vis a vis circle-wise Sanctioned strength, it is requested that the pending Rule 8 transfers in r/o JTOs(T) may be processed in cases of transfers from surplus circles to deficit circles on priority basis in accordance with the extant guidelines in the matter.
