Sub: - <u>Protest lunch hour demonstrations against the arbitrary taking over of the ALTTC and other lands</u> and buildings of BSNL, by the DoT - reg.

We wish to bring the following to your kind notice, for favour of information and necessary action.

A meeting of the All Unions and Associations of BSNL (AUAB), the joint platform of the trade unions of the Non-Executives and associations of the Executives, was held online on 24.02.2022. The meeting took serious exception to the arbitrary order issued by the DoT, vide File no.8-9/2020-Asset Mgmt dated 21st February, 2022, for the taking over of the ALTTC campus, Ghaziabad, on as is where is basis, from BSNL.

The AUAB meeting also took serious note of the fact that, the lands, buildings and office spaces of BSNL, are being arbitrarily taken over by the DoT in many circles. These actions of the DoT is violative of the decision of the Union Cabinet, on transferring of assets to BSNL. Hence, the AUAB meeting decided to organise protest lunch hour demonstrations throughout the country, to protest against the arbitrary taking over the ALTTC campus, Ghaziabad, as well as other lands, buildings and office spaces in various circles.

Subsequently, vide it's File no. 8-9/2020-Asset Mgmt dated 25th February, 2022, the DoT has directed both NTIPRIT and BSNL to maintain status quo for the time being. However, the Presidential Order issued vide File no. 8-9/2020-Asset Mgmt dated 21st February, 2022, has not been cancelled.

In view of the foregoing, it is hereby informed that, the Executives and Non-Executives of BSNL will be organising protest lunch hour demonstrations throughout the country on 03.03.2022, against the arbitrary taking over of BSNL's lands, buildings and office spaces by the DoT.
