Kindly refer to this office letter BSNLCO-TRG/11(11)/1/2020-TRAINING-Part(1) dated: 22.08.2022, vide which postponement of EPP exams in Telecom streams was conveyed. Now in view of commencement of LICE Pre basic trainings wef 17.10.22 and Master trainers training under Karmayogi project wef. OCT-22, BA Head trainings etc., feasibility to conduct various EPP courses during the period OCT-22 to FEB-23 is reviewed due to limitations of resources and trainers at various training centres.

In view of above, and in supersession of above referred letter, approval of competent authority is hereby conveyed to postpone the conduction of EPP up-gradation trainings (For all streams) for period wef. OCT- 2022 to FEB-2023 so as to allow smooth conduction of JTO (T) & JE (T) Induction trainings, Trainings under Mission Karmayogi, BA Head training etc..

The candidates whose 2 years period to qualify the EPP up-gradation online exam after issue of EPP up-gradation order, is falling during the period of postponement of EPP training/Exams (OCT-2022 to FEB-2023), shall be given suitable relaxation upto affected months, without impacting their financial upgradation benefits, by respective Cadre Controlling Authorities to qualify the EPP up-gradation exam, after resumption of EPP training/Exams again.
